## NOTICE UNDER PERSONAL DATA PROTECTION ACT 2010 (PDPA)

## **Purpose of Notice**

- 1.   - (iii) providing access to CGC's premises; and
  - (iv) complying with any legal or regulatory requirements, including but not limited to, compliance with the withholding tax requirements, or as permitted by law or authorised by any order of court.

#### **Disclosure of Personal Data**

- 4. The Company personal data held by us shall be kept confidential. However, in order to exercise our rights and obligations under the agreement/contract, to evaluate the Company RFQ/tender/proposal to CGC or to comply with any legal and regulatory requirements, we may disclose the Company personal data to:
  - (i) Departments within CGC;
  - (ii) Financial institutions and strategic partners;
  - (iii) CGC's other consultants, service providers, vendors and authorised agents;
  - (iv) Other parties authorised by the Company;
  - (v) Enforcement regulatory and governmental agencies as permitted or required by law, authorised by any order of court or to meet obligations to regulatory authorities.

The disclosure of the Company data may involve the transfer of the Company personal data to places outside of Malaysia, and by providing us the Company personal data the Company agree to such a transfer where it is required to provide the Company the services the Company have requested, and for the performance of any contractual obligations the Company have with CGC including for storage purposes.

#### **Personal Data Protection**

5. CGC shall take all physical, technical and organisational measures needed to ensure the security and confidentiality of the Company personal data. If we disclose any of the Company personal data to any entities or authorised agents, we will require them to appropriately safeguard the personal data provided to them.

#### **Retention of Personal Data**

6. CGC will retain the Company personal data for as long as necessary to fulfil the purpose(s) for which it was collected or to comply with legal, regulatory and internal requirements. Thereafter, the Company data shall be destructed or permanently deleted.
